

This email is directed to the Aftermath Foundation Board members. I've also BCC'd additional interested or connected parties.

Aaron has decided him and I have a “gentleman’s agreement” in which he won’t make all my videos live on the Growing Up in Scientology channel (the channel we both founded and he commandeered for himself) as long as I don’t tell anyone about the fact that he’s been banging hookers and doing cocaine while supposedly in an “open-marriage” – go talk to his wife Heather about this; I have a gut feeling she’s not doing much dating while Aaron philanders.

He “hid” my videos after years of me calling him out for having betrayed our agreement in starting Growing Up in Scientology together – where after my interviews, he decided he owned all of my footage(since they were shot on his phones) and that I had no say in what could or could not go up; which I provided proof of to the Board last year.

You'll see this gentleman's agreement play out - once one of you forwards this to Aaron, he'll have a conniption like he did earlier this year and send my videos live in retaliation on the channel I founded with him(The first 7 videos of the channel after the one entitled "Welcome to Our Channel").

Seeing as the Aftermath Board has been incredulous towards anyone indicting Aaron’s character (going as far as deleting any negative comments about him in the forums), I got creative. Georgia’s a one-party consent state for phone recording and the Florida/Georgia line is half an hour from where I live in Jacksonville. Attached are snippets of me talking to Aaron Smith-Levin – It’s me confronting him about his behavior and his response, along with him extorting me – additionally, I’ve provided two texts from him where he admits to this extortion in which I "have an incentive not to do anything to hurt him"(or else he’ll make all my videos live on the channel that he co-opted from me illegitimately).

He’s saying that I have to stay silent or else he’ll send my videos live again. This is literally the head of an organization whose purpose is to help Scientology victims and he’s extorting me with videos he knows affect my mental health since he directly told me he didn’t need my permission when I begged him not to post them on our channel. I’ve openly told him in numerous emails over the years that I’ve dealt with being suicidal, depression, severe Complex PTSD, Lyme disease and debilitating health issues for the last 6 years - having seen dozens of psychologists and even having to go to the ER for nervous breakdowns... and leveraging my very vulnerable Scientology story over me that he illegitimately got out of me is how he sees fit to treat me.

I can provide the rest of the conversation in which he admits that the channel was our mutual project and how he “didn’t give a flying fuck” when I begged him not to post a

standalone clip of me talking about my drug use from my interview – and the multiple times he yelled he didn't give a fuck when I brought up his cocaine and hooker penchant.

Aaron has held these videos in limbo - hidden instead of deleted from the channel. After not having contacted him for over a year, he spontaneously sent all the videos live again earlier this year and sent me scathing messages of what a low-life I was. He refused to respond to me until I called him out on his hooker and coke binging. He then hid the videos again, saying he won't delete them or sign an agreement to keep them deleted so he can "have leverage" over me as he calls it. He has also stated that for the rest of my life, I have to consult him on any Scientology story I do if it parallels anything from the interview I did with him (and if I do anything that's similar to the interviews I did with him, then he's sending my videos live again). This is sadism. I've gotten literally thousands of hours of therapy over the last 6 years for CPTSD and addiction issues and Aaron is using my very personal Scientology story he "didn't need my permission to post" as leverage over me. This is what psychopaths and narcissists do.... not people who are purportedly helping victims of a cult.

When it comes to his stance on my needing to consult him on any Scientology-related content I do in the future, he seems to think my anxiety and anger over all these videos is only related to their content - he doesn't seem to understand the fact he repeatedly told me he didn't need my permission to use the content of my interviews however he pleased was traumatizing as fuck after a lifetime in Scientology having my boundaries violated by grown-ass adults who didn't see anything wrong with 50-year old men and women poring over my masturbation habits in PC folder dossiers. Now the leader of your group is telling second-generation ex-Scientologists like me he doesn't need my fucking permission to use the story of my Scientology experience how he wants AND THEN extorting me over them while he fucks hookers and snorts coke??

This is on the heels of him soliciting 3 college-age individuals (Xxxxx, Xxxxx & Xxxxxxx) - last year to commit a Class A felony by hacking into the Belleair Mission. Two of these college-age kids were openly addicted to drugs, struggled with suicidal ideation and were on the dole from the Aftermath Foundation.... and Aaron thought it was harmless that he was colluding with them to commit a Class A felony against Scientology. Aaron even went as far as to admit he contacted his computer-savvy buddy (read: Nathan Rich) to work out the logistics of it - he then made a video playing it off like it was "all in good fun"....but then why did he refuse to take a Voice Stress Analysis with the police when both Xxxxx and Xxxxx did? and many of you know personally how Xxxxx now feels about the "help" she got from Aaron and the Aftermath.

This is on top of him illegally violating the privacy of an Aftermath applicant - Xxxxxx some years ago, going as far as publicly shaming the gay ex Sea Org member because Aaron had a personal vendetta against him. He coerced Xxxxxx into sweeping it under the rug when she tried calling him out for it.

What I recommend is you all work out your character statements for when this hits the forums and Xxxxxx needs a good rebuttal as to why a sociopath is running her show's eponymous non-profit. Something is wrong with Aaron. He needs help and shouldn't be in the position of shepherding victims of Scientology. And most of you already have that creeping suspicion and are just hoping to plead ignorant when everything comes to light.

You all deleting negative FB comments and squelching blowback against The Aftermath Foundation within the ex-Scientology community does not make you effective managers in your bid for justice – it just makes you self-righteous hypocrites with a victim complex.

I have a strong feeling you are going to regret your association with Aaron just as many already have. A year before Marty Rathbun went off the rails, Mike Rinder made him the best man at his wedding to Christie Collbran – Mike stood up at his own wedding and proclaimed he knew no man of greater integrity and stronger character than Marty Rathbun... consequent history then belied those sentiments. Unfortunately, your collective character assessment of Aaron may be equally flawed.

There are many stories of the Board turning the other cheek in the face of Aaron's malfeasance. That you've done nothing but shrug your shoulders for years makes you complicit and hypocritical.

If this isn't enough for you, I have many more texts of Aaron's extortion along with plenty more recording, constantly referencing "the deal/ arrangement we have" in which he incriminates himself.

Stating the obvious here: Extortion, snorting coke, banging hookers and nonchalantly soliciting drug-addled college kids to commit felonies for you is on the remarkably short list of shit you shouldn't be doing when you're running an organization that combats human trafficking.

Aaron will not control my Scientology story nor extort me for the rest of my life. I did not leave Scientology at 21 just to then be fucked with by the former child soldiers of Scientology's Sea Org in their bid for narcissistic self-aggrandizement.
